Investment Objective

To provide strong risk-adjusted total returns in the income producing part of the equity market with a focus on cash yield and capital preservation. The Series seeks to invest in dividend paying companies with strong cash flows that may be temporarily undervalued by the markets for a variety of reasons.

Investment Strategy

The Series invests at least 80% of its assets in equity securities and equity-related instruments, under normal circumstances. For purposes of the Series' 80% investment policy, equity securities and equity-related instruments include common stock, preferred stock, securities convertible into common and preferred stock, non-convertible preferred stock, American depository receipts (ADRs), securities or other instruments whose price is linked to the value of common stock or other equity securities, securities of master limited partnerships (MLPs), business development companies (BDCs), and real estate investment trusts (REITs). These equity investments may be in issuers involved in special situations, such as companies involved in initial public offerings, tender offers, mergers and other corporate restructurings or management changes. In addition, the Series may invest up to 20% of its assets in options to enhance returns, and in fixed-income securities, including distressed debt, convertible bonds, short duration government bonds, money market funds, and corporate bonds. The Series may invest in fixed income securities, including corporate bonds and convertible bonds, with any credit rating, including high yield ("junk bonds") or, if unrated, determined by Callodine Capital Management, LP ("Callodine" or "Sub-Advisor"), the Sub-Advisor of the Series, to be of comparable quality.

Accordingly, performance shown for the Class I and Z shares is the Predecessor Fund's performance unadjusted. The performance shown for the Class S Shares is the Predecessor Fund's performance adjusted to reflect the fees and expenses of the Class S Shares.

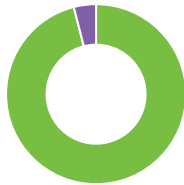

Commentary

The Callodine Equity Income Fund returned -5.07% in the three months ended October 31, 2023, outperforming the broader S&P 500 and S&P 500 High Dividend Index, which returned -8.25% and -12.51%, respectively. From our perspective, broader equity markets underperformed as investors seem to be coming to grips with the notion that higher real interest rates should and will have an impact on both cost of capital and resulting valuations. We believe that the Fund's outperformance can be attributed to our team's ability to find attractively valued stocks that protected capital well and delivered attractive, sustainable dividend income in a declining market.

Callodine Equity Income Fund continues to be overweight Healthcare, Financials and Energy given the relative value we see in those sectors in the current environment. Conversely, the Fund is underweight Industrials, Materials, Communication Services and Technology stocks. This industry positioning is reflective of our view as to which sectors are priced for a late-cycle environment, and which have not experienced the degree of multiple compression that we would have anticipated given the current rate environment and deteriorating fundamentals that we see in certain pockets of the U.S. economy (e.g. Software Services).

Top contributors for the three month period included Barings BDC (BBDC), Energy Transfer (ET), and Blue Owl Capital (OWL), while top detractors included Viatris, Inc. (VTRS), Perrigo Co. Plc (PRGO), Baxter International (BAX) and Douglas Emmett, Inc (DEI).

Several new positions were added to the strategy during the period, including Atlantica Sustainable Infrastructure (AY), Kraft Heinz Company (KHC), Shell (SHEL) and Wolverine World Wide (WWW). Several names were also removed from the strategy during the period, including Blackstone Secured Lending Fund (BXML), Comcast Corporation (CMCSA) and Ovintiv (OVV). We will continue to invest with a long-term mindset and actively adjust position sizes as needed.

As we head into year-end, our team continues to focus on identifying stable, cash flowing businesses where we can source yield-at-an-attractive price. We believe that the opportunity set for our target universe is appealing in the context of the current market environment and will continue to try and deliver attractive risk-adjusted returns to our investors with a high component of that return coming in the form of income.
